CALL FOR PAPERS

Indian Health Economics and Policy Association (IHEPA) invites policy relevant theoretical and empirical research papers. Major themes of the Conference are:

☐ Health System: Issues of Human Resource, Access and Coverage

Strengthening health care continues to be one of the serious challenges facing India's health care system. Strengthening the public health system has been at the forefront of several policy formulations. However, the public health system in India is crippled by issues of human resources, access, coverage and governance. National Health Mission was a major initiative to address various systemic issues including budgetary allocations to the health sector. Health system studies are relatively scarce in India. Papers analysing issues concerning the health system both public and private are welcome in this theme. Analytical papers on these issues and best practices in overall perspectives are also encouraged.

☐ Health Care Financing including Health Insurance

With out-of-pocket expenditure dominating the health care financing in India, addressing the increasing health care burden has been a serious challenge. The National Health Protection Scheme (NHPS) recently announced by the Government of India has considered insurance as a viable option to address the health care burden of the poor. There are other health insurance schemes operational in different parts of the country with government support. It is important to have a new look at health care financing issues within the context of various policies and programme interventions. Papers dealing with health financing issues are welcome under this theme.

☐ Health Equity

Socio-economic factors that influence health of a person have been a matter of intense research in India over the last several decades. With the availability of many data sources in recent years like NFHS, NSSO and IHDS, a more nuanced understanding of health equity is possible. Health also needs to be understood not merely as death or disease but with a public health perspective. Sound analytical papers on health equity are expected under this theme with a definite contribution to the vast existing studies on this issue.

☐ Kerala's Health System: Achievements and Challenges

For the last several decades, Kerala's creditable achievements in health status have been a matter of both national and international attention. At the same time, with rapid changes in socio-economic and behavioural patterns, Kerala's health system is also facing several challenges. Under this theme, papers relating to issues that confront Kerala's health system as well as on its health achievements will be discussed.

☐ Other Related Issues

Papers on issues such as public health, nutrition, communicable and non-communicable diseases, global health relevant to the Conference themes are also solicited.

GUIDELINES FOR SUBMISSION OF THE PAPER

We invite an extended abstract of around 4 pages (less than 1500 words) to be uploaded online using IHEPA website (www.ihepa.in) by September 30, 2018. The abstract should reflect the whole paper including context, objectives, methodology and main conclusions. The abstracts submitted will be screened by a Panel of Reviewers of IHEPA for acceptance to the Conference. 



The missing girls in India are not a new phenomenon. The British passed an Act to check female infanticide more than 100 years ago. Since 1960, India's birth sex ratios have progressively declined from 994 to 910, implicating life-affecting gender violence. Backed by extensive field research, data and interviews, this book explores girl child deselection through cultural neglect, female infanticide and foeticide, and the role of caste and religion.

The book spans critical socio-historical contexts and examines the practice of selective right to life. It views the effects of militancy and *khaap* panchayats, and studies women's rights discourses and protective legal reforms. The gender imbalance is mapped globally and analysed in the specific conditions of the Indian states of Punjab and Haryana. The book examines the inter-linkages of gender hierarchies with male child preference and warns that theoretical analyses limited to female foeticide alone cannot address gender inequalities or change the cycle of violence.

This will be valuable to scholars and researchers of gender and women studies, sociology, politics, and population and demographic studies. It will also be indispensable for women's rights activists, NGOs, policy makers, government bodies, and those studying health and family planning.
